Commercial and Craft Space Rules & Regulations

GENERAL RULES

- Exhibition dates: August 8th, 9th, 10th, 2008
- Hours of operation: Friday: 9 a.m. to 10 p.m. (grounds open till midnight)
Saturday 9 a.m. to 10 p.m. (grounds open till midnight)
Sunday 9 a.m. to 6 p.m.
- All booths are to be staffed at all times during hours of operation
- Set up time: Thursday August 7th 10:00 a.m. to 9:00 p.m.
- Release Time: Sunday August 10th at 6:00 p.m.
- There is absolutely no on-grounds parking
- **There is absolutely no vehicular access to the south end of the buildings at any time.**
- **It is your responsibility to provide a dolly if needed to bring supplies to your booth.**
- Electrical by request for indoor booths only. Please bring ample extension cords.
- Security is provided on the grounds 24 hours a day from 9 p.m. Aug. 7th to 9 a.m. Aug. 11th.
- Although security is provided, Chilliwack Exhibition will not be responsible for any damages or theft of any property.
- The Chilliwack Exhibition is not responsible for items or belongings in your display.
- All signage should be neat and easy to read.
- The Chilliwack Exhibition reserves the right to censor.
- Only products listed on the contract may be sold, displayed or advertised – all other items listed on application may not be approved. We do not grant exclusivity for any products.
- You must promptly close any booth, which in the sole discretion of the Exhibition Management is inappropriate, hazardous, or in violation of Exhibition rules and regulations, including those established by the Health and Fire Districts.
- Your booth must be left empty and clean after the event. Failure to do so may jeopardise any future contract.
- Grounds and location map and Exhibition Schedule will be available on arrival

CRAFT SPACE

- This space is intended to give opportunities to the home based crafter, and is not meant for business operations.
- All items must be grown, baked, or made at home by you. Can not be a purchased product being resold by the vendor.
- Items will be juried. Please submit a photo of items for sale along with your application.
- You will be provided with one skirted table and two chairs.
- If time permits, passes will be mailed on receipt of final payment.
- A vendor is ineligible for a craft space if:
 - this is a primary source of income
 - the item has been purchased for resale
 - you operate a store front

INSIDE COMMERCIAL SPACE

- If time permits, passes will be mailed on receipt of final payment
- Booths will have blue and white pipe and drape with side wings, access to power (if requested on your application), a skirted table and two chairs

OUTSIDE COMMERCIAL SPACE

- if time permits, passes will be mailed on receipt of final payment
- tables, chairs, and electricity are not provided
- Your stock is your responsibility overnight.
- The Chilliwack Exhibition requires all displays/equipment to be visually appealing. (i.e. no tarps, garbage etc.)
